



## DISTRICT OF VANDERHOOF BYLAW NO. 1101, 2011

---

A bylaw to provide payment of indemnities to members of the District of Vanderhoof Council.

---

The Council of the District of Vanderhoof in open meeting assembled enacts as follows:

### 1. Definitions

**annual indemnity period** means from the first Monday after December 1<sup>st</sup> until the first Monday after December 1<sup>st</sup> the following year, and every one year period after that;

**Council** means the Council of District of Vanderhoof;

**Council Members** means the Mayor and Councillors of the District of Vanderhoof.

### 2. Indemnity for Council Members

An annual indemnity to Council members may be paid out of annual revenue as follows:

i) to each Councillor

\$11,000 for the annual indemnity period beginning December 2011

ii) to the Mayor

\$33,000 for the annual indemnity period beginning December 2011

iii) for the annual indemnity period beginning 2012 and beyond

the indemnity for each Councillor shall be adjusted annually for the CPI for British Columbia.

the indemnity for the Mayor shall be adjusted annually to equal three (3) times the annual indemnity amount for a Councillor.

### 3. Payment of indemnities

Indemnities for Council members may be paid monthly in equal installments.

### 4. Partial Term of Office

The annual indemnity for Council members shall be prorated when the Council member does not hold office during the entire indemnity period.

### 5. Allowance for Expenses Included in Annual Indemnity

One third of the annual indemnity paid to a Council member shall be paid as an allowance for expenses incidental to the discharge of the duties of office.

### 6. Review of Bylaw

This bylaw will be reviewed by an independent Task Force in the third year following the Local Government Election in time to permit any recommendations to be implemented prior to the next Local Government Election.

### **7. Effect of Bylaw**

This bylaw takes effect on Monday, December 5<sup>th</sup>, 2011.

### **8. Repeal**

The District of Vanderhoof Council Indemnity Bylaw No. 870, 1998 and Council Indemnity Amendment Bylaw No. 902, 2000 are hereby repealed in their entirety.

### **9. Citation**

This Bylaw may be cited for all purposes as the District of Vanderhoof Council Indemnity Bylaw No. 1101, 2011.
