



**DISTRICT OF VANDERHOOF
BYLAW 1113, 2012**

A bylaw to amend the Corporation of the District of Vanderhoof Sewer Connection Rates and Supply Regulation Bylaw No. 126, 1953 as amended by Bylaw No. 719, No. 839, No. 948, No. 970 and No. 980.

The Council of the District of Vanderhoof in open meeting assembled enacts as follows:

1. User Charges

That Section 2 of Bylaw No. 126, as amended by Bylaw No. 980 is hereby deleted in its entirety and the following substituted therefore:

The owner of each and every parcel of real property upon which there is now or hereafter may be situated one or more of the establishments described in the following, shall in respect of each establishment pay or cause to be paid to the District for the use of sewer supplied by the District to or for such establishment or establishments the following sum or sums:

| Each theater, warehouse, welding shop, bus depot, office, RCMP office, church, railway station, retail store; however, retail stores and offices not mentioned in (a) to (f) above, that share a common corridor shall pay 1/2 of the per annum rate. | |
| (h) LAUNDRY, CAR WASH | \$927.00 per annum |
| Each laundromat or independent car wash | |
| (i) RECREATION, BEAUTY SHOP | \$278.00 per annum |
| Each bowling alley, pool hall, barber shop, or beauty parlor | |

(j) APARTMENTS \$ 106.00 per annum
Each residential unit

(k) HOSPITAL \$3,756.00 per annum

ANY PREMISES HOUSING A MULTIPLE USE, EXCEPT AS OUTLINED ABOVE SHALL BE CHARGED FOR EACH USE.

2. Discount

An early payment discount of 10% will be allowed on payments received prior to the close of business on October 31st of each year.

3. Effective Date

This bylaw shall take effect January 1, 2012.

4. Repeal

The District of Vanderhoof Sewer Rates Regulation Amendment Bylaw No. 980, 2005 is hereby repealed.

5. Citation

This bylaw may be cited as the District of Vanderhoof Sewer Rates Regulation Amendment Bylaw No. 1113, 2012.
